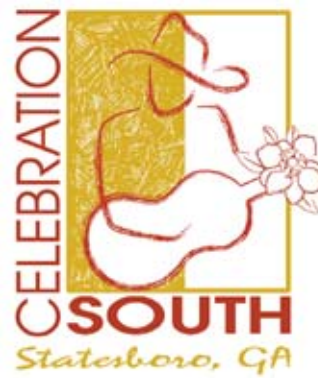


Celebration South 2010 Vendor Information

Non-profits, artists, craft persons, musicians, are **\$20** (products by artists, craft persons, and musicians must be their own creation, and the creator of the product must be present at the booth. Demonstrations are welcome. Non-profits wishing to provide a service (diaper changing table for instance) may be FREE.
